President's Report, submitted by Kyle Fuhrman:

- Review/accept meeting minutes accepted by all present
- Upcoming meetings Parent's meeting.
 - The Parent's meeting will be mandatory for at least one parent to attend and will be held on 2/26 during player evaluations from 2pm to 6pm
 - Jen to send out a Save-the-Date for evaluations (2/26) to all registered players now and after registration closes
 - Registration is closing on 2/16/22
 - SGBA board to create the agenda for the Parent's meeting at the February meeting
- 14-18 age group/tournament teams
 - 10U (Pat Craig's team) will continue to play in tournaments and in York county games.
 - For 14–18-year-olds, SGBA will decide if we continue to play legion after the next legion meeting
 - If SGBA Does not participate in legion, we will participate in York County baseball
 - For tournament teams, additional money per player will be needed to play in the tournaments and they will receive 2 different jerseys – 1 for York county games and 1 for tournament games. This information will need to be clearly communicated to all families playing on tournament teams
- Field committee Field updates
 - North Codorus (including but not limited to the following items)
 - Upper back drop needs replaced, bad lips at all bases, add sod, raise mound, add dirt to home plate, rotate pitcher's mound, back stop fence is curling
 - Lower Net up for batting cage, remeasure/re-square needed, rotate mound, bad lip at all bases, fence at 1st base curled, entire field needs to be leveled, snow fence applied around drains
 - NC supplies Diamond-Tex and SGBA will spread it on the fields
 - Mike Slagel is the new contact for NC the rec board has been disbanded
 - Josh Fishel to complete the application for field usage for NC
 - Spring Grove Borough Fields
 - Josh will inspect and report to SGBA within the next week
 - The shed window is broken at the borough field
 - Jefferson Fields
 - Benches are in need of replacement, small field need to cut out at bases, suggest to beef up dugouts with stone/gravel, fields need tilled & leveled, need Diamond-Tex
 - Pat has plans to modify the storage areas as well.
 - Heidelberg fields
 - No work needed on these fields this year
 - Paradise Field
 - Needs tilled, leveled, Diamond-Tex added and shed needs to be organized.
